Wildfires

Mimi Walters INTRODUCED H.R. 4397 to provide tax relief for those whose homes and property were lost or damaged in the recent wildfires. The bill will:

- ▶ Allow wildfire victims to deduct property loss/damages from their taxes.
- ▶ Temporarily suspend the limit on charitable contributions.
- ▶ Provide a tax credit for employment relief.
- ▶ VOTED for \$36.5 billion in emergency funding for hurricane and wildfire disaster relief.
- ▶ VOTED for \$576.5 million to U.S. Forest Service and Interior Department for active wild fire suppression activities.
- ▶ REQUESTED the Administration increase federal funds to California for protective measures and direct federal assistance for the October wildfires. The Administration approved this request on November 22, 2017.
- ▶ WORKED to obtain an additional \$4.4 billion in wildfire relief funds in the supplemental disaster bill.

Veterans, Military Families

- ▶ VOTED for a 2.4% pay increase for our troops, the highest pay increase since 2011.
- ▶ VOTED to ensure GI bill benefits don't expire.
- ▶ VOTED to allow eligible veterans to use benefits for non-traditional educational courses (like coding classes).
- ▶ VOTED to expand education benefits for national guardsmen and reservists.
- ▶ VOTED to end backlog in VA appeals by streamlining the disability appeals process.
- ▶ VOTED to make it easier to fire poorly performing VA employees and expand whistleblower protections.

Senior Citizens

- ▶ VOTED in favor of the Protecting Seniors' Access to Medicare Act, which would eliminate the Independent Payment Advisory Board - an unelected body of bureaucrats who currently have the authority to cut Medicare.
